3. Use a cloth to apply the product on the animal's face.
4. Reapply every 2-3 days or as needed before the animal goes outside.
5. Reapply whenever the animal is thoroughly wet.
6. Safe for daily use, if desired.

Caution: Keep out of the reach of children and animals. Avoid inhalation and contact with eyes, nose and mouth.
