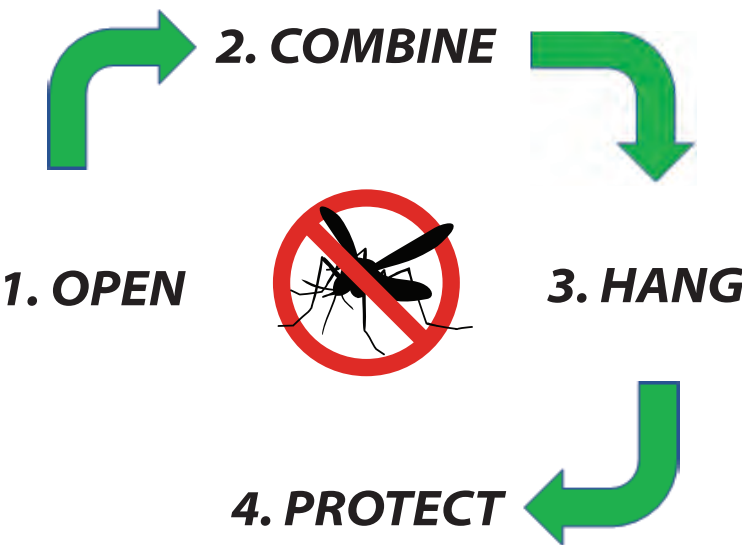

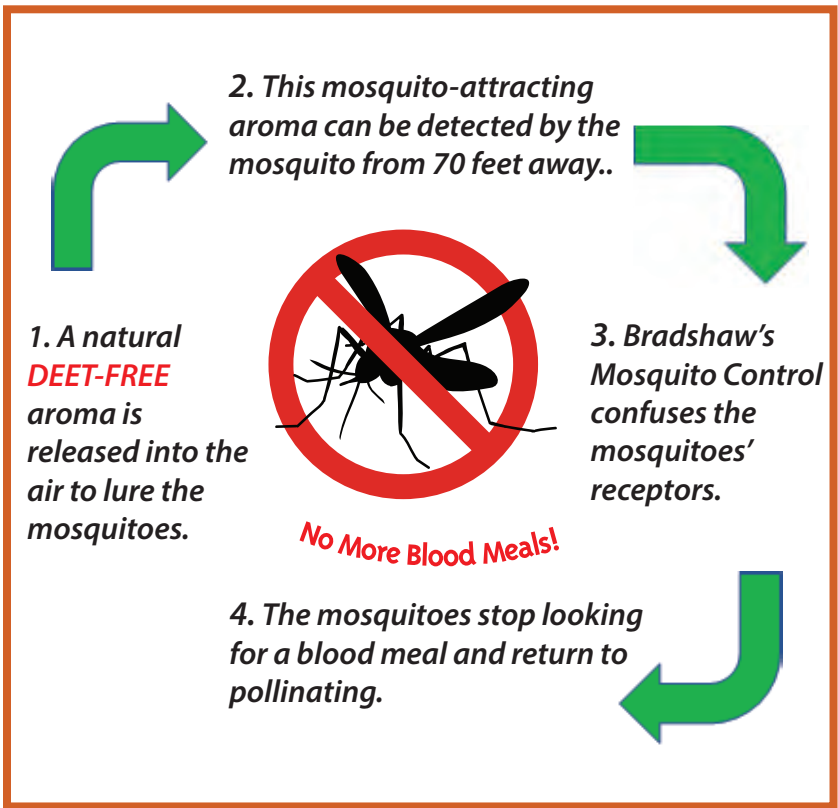

For best results:

- Works best with no barriers (walls, hedges, fences or buildings) Between the **Bradshaw's 4 Ring Protection** pouch and the areas you want to protect.
- Ensure pouch is hung in a shaded area at least 20' away and 4' high from where you want a Safe no-bite™ ZONE.
- For heavy infestations or larger areas that need protection, use additional **Bradshaw's 4 Ring Protection** pouches.

CAUTION: Keep out of reach of children. Outdoor use only. Not for consumption. Do not get in eyes. Wash hands with soap and water after handling.

If in eyes: Hold eye open and rinse slowly and gently with warm water for 15-20 minutes. Remove contact lens if present, after the first 5 minutes, then continue rinsing eye. If irritation persists, call a poison control center or a doctor for treatment advice.

If swallowed: Call a poison control center or a doctor immediately for treatment advice. Do not give anything by mouth to an unconscious person. Do not induce vomiting unless told to do so by the poison control center.
