DIRECTIONS FOR USE:

SHAKE WELL BEFORE EACH USE.

ANT & ROACH TREATMENT: Kills common household ants and cockroaches. Hold container upright and aim nozzle at red dot on rim. Press button firmly to spray. Spray on ants and cockroaches to kill by contact. Also, spray cracks & crevices where ants and cockroaches have been seen such as around sinks and plumbing, under and around appliances, behind cabinets and baseboards and around waste containers. When treating for ants, also spray points of entry and trail. Repeat treatment as ants and cockroaches are seen.

NOTE: As with most household products, this product will stain any surface that water alone will stain. Test fabrics in an inconspicuous area before using. Do not use on vinyl siding or window or door casements made of vinyl molding. Be careful when spraying around plants as new growth or tender foliage may be harmed.

STORAGE & DISPOSAL: Store in a cool, dry area away from heat or open flame and inaccessible to children and pets. When container is empty, recycle if available. Do not puncture or incinerate.

PRECAUTIONARY STATEMENTS: This product contains wintergreen oil which may be harmful if swallowed and may irritate skin. Avoid contact with eyes & skin. This product contains plant oils that are inherently fragrant. Use in well ventilated areas. Breathing vapors or mists may trigger breathing difficulty in asthmatics and others with allergies, physiological sensitivities or medical conditions. After use, vacate the treated area and allow sprays to dry before re-entering. For people who are fragrance sensitive, test a small application before using over a larger area. When used indoors, wipe up excess spray to avoid slipping.
