Spray targeted areas, such as under cabinets, in basements or crawl spaces, around the exterior of structures or vehicles, or bottom of fencelines, garden areas, trash containers, attics—or anywhere micel and rats may be trailing or nesting liberally until if becomes damp. Treatment should be repeated after the door diminishes.

USE RESTRICTIONS: For use only in Non-Food areas. Do not treat surfaces likely to be contacted by food. Do not treat toys and stuffed animals with product.
