#### DIRECTIONS FOR USE:

Mix at a 20% to 30% dilution rate (approximately 26 to 39 fl. oz. per gallon) in water. Apply in full sun, when plant is active after morning dew. Protect any desired vegetation. Spray weeds or grass until wet. Never apply after or before an imminent rain event. Do not mix with any other pesticides. If a desirable plant is accidentally sprayed, rinse off immediately with water. Only for application directly to weeds or grass as it will kill or damage all plants. Perform a jar compatibility test when mixing with other spray materials. If using well water, reduce to pH 4 before mixing the product using an organic pH reducer such as a citric acid adjuvant.

#### **SHAKE WELL BEFORE EACH USE.**

#### **FOR USE ON:**

Driveways, walkways, mulch and gravel beds, patios, pavers, fence lines, around shrubs and trees, and areas where unwanted weeds and grass are.

**PRECAUTIONARY STATEMENTS:** Avoid getting in eyes, on skin or on clothing. This product requires the use of side shield safety glasses and gloves. Use with adequate ventilation. Harmful if swallowed.

**FIRST AID:** If skin contact occurs, remove contaminated clothing and wash with large amounts of soap and water. If in contact with eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation. Wash clothing before re-use.

**ENVIRONMENTAL HAZARDS:** Caution: potential spray drift can affect non-target organisms. Do not apply when honeybees or other pollinating insects are foraging. To protect the environment, do not allow to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash off the treatment area. Rinsing application equipment over the treated area will help avoid run off to water bodies or drainage systems.

**STORAGE:** Store in original containers only in cool areas at 40 - 80°F. Do not contaminate water, food or feed by storage or disposal. Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Triple rinse (or equivalent) and add rinseate to spray tank. Do not reuse empty container.
