**INSTRUCCIONES DE USO:** Antes de mezclar, agitar bien el concentrado. Si se aplica en exteriores, rociar las plantas por la mañana temprano o al atardecer para evitar la parte más calurosa del día. Evitar rociar con temperaturas superiores a los 90°F. Si se aplica en interiores, mantener las luces y los ventiladores apagados por 2-3 horas después de rociar.

**USO PREVENTIVO:** Mezclar al 0.25% o 10 mL de concentrado por cada galón de agua. Rociar abundantemente las hojas y tallos de la planta que está tratando hasta que goteen. Agitar durante el uso. Repetir este proceso cada 7 días para prevenir plagas.

**USO CURATIVO:** Mezclar al 1.0% o 40 mL de concentrado por cada galón de agua. Rociar abundantemente las hojas y tallos de la planta que está tratando, incluido el dorso de las hojas, hasta que goteen. Agitar durante el uso. **PRECAUCIÓN/PRIMEROS AUXILIOS:** Evitar colocar el producto cerca de calor extremo, chispas y llamas expuestas. Evitar que entre en los ojos o toque la

piel o la ropa. Peligroso si se ingiere. Se recomienda usar guantes impermeables para evitar el contacto prolongado de la piel con el concentrado. Si hay contacto, lavar con mucho jabón y agua 15 a 20 minutos. Si entra en los ojos enjuagar repetidamente con agua limpia durante 15 minutos. Consultar al médico si persiste la irritación.

**ALMACENAMIENTO:** Mantener el producto en su recipiente original en un lugar fresco y seco lejos del sol directo. Guardar en temperaturas entre 65°F y 80° F. No congelar.

**DESECHO:** Desechar el desperdicio de acuerdo con las leyes y regulaciones ambientales locales, federales y estatales. Reciclar lo botella al terminar y no volver a usar.

**DIRECTIONS FOR USE:** Prior to mixing, shake the concentrate well. For outdoor application, spray plants early in the morning or evening to avoid the hottest part of the day. Avoid spraying in temperatures over 90°F. For indoor application, keep lights and fans off for 2-3 hours after spraying.

**PREVENTATIVE:** Mix at 0.25% or 10 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating until there is runoff. Shake during use. Repeat this process every 7 days to prevent pests.

**CURATIVE:** Mix at 1.0% or 40 mL of concentrate per 1 gallon of water. Thoroughly spray the leaves and stems of the plant you are treating, including the undersides of leaves, until there is runoff. Shake during use. Repeat this process every 3-5 days, as necessary, until the problem is eradicated.

No limitation on the number of applications per growing cycle. No need to add a wetting agent.

**PRECAUTIONS/FIRST AID:** Avoid getting product near extreme heat, sparks and open flames. Avoid getting in eyes or on skin or clothing. Harmful if swallowed. Direct eye contact may cause irritation.

Impervious gloves are recommended to prevent prolonged skin contact with concentrate. If contact occurs, wash with large amounts of soap and water for 15-20 minutes. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.

**STORAGE:** Keep product in its original container in a cool, dry location away from direct sunlight. Store in temperatures between 65°F and 80°F. Do not freeze.

**DISPOSAL:** Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Recycle bottle when empty and do not reuse.
