# FULZYME™ - SP

## Product Information

**FULZYME - SP** is a microbial inoculant containing beneficial microorganism to promote plant growth.

### CONTAINS NONPLANT FOOD INGREDIENTS

*Bacillus subtilis*.....3 x 10<sup>9</sup> cfu/g

## Directions and General Recommendations

**TRANSPLANTING DIP:** Dilute **FULZYME - SP** at 13.3 oz. per 10 gal (100 grams per 10 L) of water and dip the plant roots in the solution before transplanting.

**CUTTINGS AND BULBS:** Dilute **FULZYME - SP** at 13.3 oz. per 10 gal (100 grams per 10 L) of water and dip the cuttings or bulbs prior to planting.

**MANUFACTURING OF POTTING SOIL:** Mix 1 part of **FULZYME - SP** per 500 parts of potting soil. DO NOT steam or sterilize potting soil after mixing with **FULZYME - SP**.

**FOLIAR APPLICATION:** Apply **FULZYME - SP** at 1-2 lb. per acre (1-2 kg per hectare) in enough water to the foliage of plants.

**SOIL APPLICATION:** Apply **FULZYME - SP** at 1-2 lb. per acre (1-2 kg per hectare) in enough water to the soil around plants. **FULZYME - SP** can be applied through various irrigation systems and as a side dress.

**FULZYME - SP** can be used many crops including but not limited to avocado, banana, berries, brassica vegetable, bulb vegetable, cereal grain, citrus, corn, cotton, cucurbit, forage crops, fruiting vegetable, kiwi, leafy vegetable, legume vegetable, mango, melons, nut trees, ornamental, papaya, peanut, plantain, pome fruit trees, rice, root and tuber vegetables, small fruit, sorghum, soybean, strawberry, sunflower, tomato, stone fruit, and vegetables.
